Conference Info

Language. The conference will be in English (no translation).

Location. The hotel is located 100m from Versoix Rail Station. The conference facility is located 150m. from Mies Rail Station.

Fees. The standard fees are divided into **two parts**: the conference & hotel. The conference fee is CHF/EUR 150 (including lunch/dinner), which should be paid to the Alliance Lawyers Account (details below).

Accommodation. By mentioning "Geneva Conference", you can secure a special rate of CHF/EUR 360 for two nights in a single room. Alternatively, a room with two separate beds is offered at CHF/EUR 380 for two nights. We give you the option to share this cost with another participant. Please consult the hotel regarding the possibility of extending your stay or booking for just one night.

For students, the fees are CHF/EUR 90, covering both the conference fees and accommodation (at the parish of Versoix-Mies). However, beds are not provided, so please remember to bring your own mattress and sleeping bag. Payments should be made only to the Alliance Lawyers Account (details below).

Registration. Please be aware that availability is limited to only 60 seats. Therefore, we recommend registering as early as possible to secure your place. You can register via email at secretariat@bsb-avocats.ch. Make sure to mention 'Geneva Conference' in your correspondence.

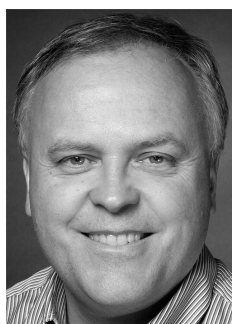

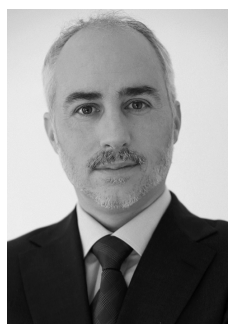
